# WHO IS JOHN DOE?

If you are in an accident and the driver fled the scene (known as a hit-and-run), you may be able to file an injury claim against the negligent party, even if they are unknown. An

uninsured motorist claim can be made against your own insurance company and the suit can be filed against the unknown driver by naming them "John Doe".

To receive compensation in a hit-and-run, you MUST have automobile insurance in your name or on the car you are driving. If the claim proceeds into litigation and ultimately goes to court, John Doe's defense attorney (hired by your insurance company) sits next to an empty chair for the proceeding. Of course, there will be no defendant available to testify, but the defense attorney may call witnesses or hire experts to contest your claims. They may try to show that you were contributorily negligent. If they can prove that you were at fault, even by the tiniest measure, then they are not required to compensate you for your injuries under Virginia law.

It is crucial to hire a personal injury attorney in these situations to help you make the best recovery possible! If you are awarded damages, your insurance company will pay you, and your premiums should not go up. Your policy limits may determine or limit the amount you can recover. We recommend getting the highest limits you can. When you buy liability coverage in Virginia, you get the same coverage in uninsured coverage unless you opt for less underinsured coverage. We have handled hit-and-run cases where our clients had high limits and it makes a BIG difference in the recovery for the client.

## \$750,000 HIT-AND-RUN CASE

Our client was driving in Richmond, VA when he was rear-ended by someone. The other driver fled the scene of the accident and was never identified. In the collision, our client sustained a significant exacerbation of a pre-existing back and neck injury. He was treated at a nearby hospital for two days after the accident and was diagnosed with cervical radiculopathy, prescribed pain medication, and released. With back pain radiating into his legs, our client followed up with specialists.

After MRIs were reviewed, it was decided that a lumbar fusion surgery was necessary. The surgery was successful and our client noticed immediate improvement with his pain. After several months though, pain returned to his



back and pelvis. He was given injections over a long period of time and was prescribed physical therapy. This case settled for \$750,000. Fortunately, for this client, the limits on his vehicle policy were high so we were able to make this recovery. Be sure to check your own policies to make certain they're high in case you're ever hit by an uninsured driver or involved in a hit-and-run!
